IMPORTANT

All club members are required to read and sign an insurance waiver as a condition of membership. You will be required to sign it only once, so long as you maintain your membership. If your membership lapses, you will be required to sign a new waiver form upon rejoining. Guests must sign a new waiver each time they visit our range. A waiver form may be printed out directly from our website www.tulprpc.org Click the "Membership" menu at the top of the "Home" page.

Policy and procedures for sponsoring/recommending new candidates for club membership.

Our club's by-laws require that someone who wishes to become a club member must have a sponsor (*someone to recommend them*), to insure that new applicants are known to the sponsoring club member as a responsible person of good repute, who will respect club rules and property, and who's membership will not be detrimental to the interests of the club. The club member (sponsor) is responsible to instruct and supervise their membership nominee in following the procedure for attaining club membership as outlined below.

PROCEDURE:

1. All new nominees for membership must have a sponsor, who has been a club member, in good standing, for a period of at least one year.
2. All new nominees for membership must complete a membership application and insurance waiver form. (*both available to print out from the "**Membership**" page of the club's website www.tulprpc.org*).
3. The sponsor's name must be included on the membership application in the section: **"Recommended by"**.
4. The sponsor must co-sign/endorse the insurance waiver form in the space provided, and so indicated, on the signature page, adjacent to the applicant's signature.
5. After mailing your completed membership application, insurance waiver form and payment to our PO Box, the new membership nominee, and their sponsor, must attend the next scheduled club meeting, or if unable, to attend a subsequent meeting of their choice. We must receive your application, insurance waiver form and payment at least ten days prior to the meeting you will be attending, since time is required to process your paperwork prior to the meeting.

The sponsor will introduce the nominee to the attending club members. After the introduction, the nominee will be asked to, momentarily, step out of the meeting room. The club members attending must ratify the nominees membership by vote, after which, the new nominee will be invited back into the meeting and will receive their membership card.

6. Again, the new nominees membership application, insurance waiver forms and check payment must be sent to our PO Box, at least 10 days prior to the regular club meeting they wish to attend. Regular club meetings are the first Thursday of each month, at our clubhouse located at Leonard & Walter Sts., Pine Grove, at 7:00PM. **Neither the club member (sponsor), nor the new membership nominee will be contacted. It is your responsibility to submit the required paperwork and payment and to be in attendance at the first meeting after sending in said documents and payment.** If, for whatever reason, the new nominee and/or their sponsor is unable to attend the next meeting subsequent to sending in their payment and documents, they may attend a future meeting, however, in this event, it would be best to notify us by e-mail of your intentions.
